## Pet Sales Contract And Agreement

**Seller agrees to sell Buyer a puppyborn:**

1. The Buyer agrees to provide a comfortable environment, prompt medical attention, proper grooming and responsible care. This includes keeping this puppy/dog parasite free and up to date with inoculations, proper nutrition, which consists of a good quality feed given at regular intervals, and fresh water available at all times. The Buyer promises to provide a safe environment for the dog, and never allow the dog to roam freely without proper fencing or supervision.
2. The Seller guarantees this puppy/dog to be of sound health and temperament at the time of this sale. A health record of all shots and wormings will be provided by the Seller. The Buyer agrees to take this dog to a licensed veterinarian of his choice within 72 hours for a physical examination. Should puppy/dog be determined to be in ill health, the cause of which is clearly attributable to the Seller, the dog may, upon signed written diagnosis from veterinarian, be returned for refund of the purchase price within 72 hours excluding price of transport. In this case contact the Seller immediately. Second vet opinion may be requested. The Buyer agrees to not give the puppy/dog any medicaments, nor take the dog/puppy to any veterinary examination within this time without prior consultation with the Seller. Any condition that is minor, correctable, or a breed related minor condition is not covered and any condition which will go away as the puppy gets older is not covered. We will not accept responsibility for any harm that comes to the dog once in your possession such as accidents, electrocution, heat related conditions or any other related actions. Seller does not accept responsibility for contagious diseases diagnosed after 3 days from the date of possession.

**What is covered:** 1. Fatal viruses for 3 days (72hours) from its arrival. These are: Distemper, Parvo and Corona virus.

**What is not covered:** Coccidia, giardia, kennel cough, cold, pneumonia and other bacterial diseases are not covered.

Diseases that are not life threatening and do not adversely affect the health of the animal are not covered. Such diseases are localized demodectic mange, grade 1-2 heart murmur, grade 1-2 luxatin patellas, cherry eye, localized mange, bladder stones, inverted eyelids, inverted tails, testicle problems. The quarantine does not cover what in the Bulldog breed is considered normal: cherryyeye, entropion, loose hips, demodectic mange and skin allergies.

3. The Buyer agrees to contact the Seller immediately if any questions or concerns arise about the dog, such as health. The buyer agrees to keep the seller informed of any treatment as it occurs. This provides the Breeder/Seller with an opportunity to follow up on puppies and gives us important feedback and information on the health of our dogs for us
4. Due to recent global changes caused by COVID-19 outbreak there might be an extra waiting period for some destinations. For affected destinations buyer agrees to wait necessary time needed based on current situation/law. Seller agrees to wait and hold the pup reserved for the buyer until the situation is back to normal.

The preceding paragraphs contain conditions established to ensure the well being of the dog and well reputation of our company.
